Manurewa Intermediate (1353) Enrolment Scheme

Effective from 1 January 2018

The guidelines for development and operation of enrolment schemes are issued under section 11G (3) of the Education Act 1989 for the purpose of describing the basis on which the Secretary's powers in relation to enrolment schemes will be exercised.

Home Zone

All students who live within the home zone <u>described below</u> and <u>shown on the attached map</u> shall be entitled to enrol at the school.

Starting at the intersection of Browns Road and Great South Road, travel west along both sides of Browns Road and north along Dalgety Drive. Travel across country west to Bolderwood Place and continue west to Roscommon Road (Mayo Road, Athy Place, McVilly Road, Chonny Crescent included). Travel south along the centre of Roscommon Road (250 - 504, even addresses only included) and east along Weymouth Road (odd addresses 257 and below, even addresses 148 and below included) to Friedlanders Road. Travel south along Friedlanders Road (Eddowes Street and Ruby Street included), west along Dr Pickering Avenue (odd addresses 5 and below, even addresses 10 and below included), and south along McDivitt Street to Mahia Road. Travel east along Mahia Road (odd addresses 153 – 63, even addresses 132 – 74 included) to Tawa Crescent (Hobart Crescent odd addresses 25 and below, even addresses 26 and below included: Coxhead Road odd addresses 157 and below, even addresses 108 and below included; Hooks Road included). Travel north along Tawa Crescent to Manurewa South School, and follow the southern boundary of the school east to Totara Road. Travel north along Totara Road (even addresses 28 and above, odd addresses 15 and above included) and east along Puriri Road to Christmas Road (Rimu Road odd addresses 33 and above, even addresses 30 and above included). Travel south along Christmas Road (odd addresses 39 and above, even addresses 62 and above included) to Olive Street (included) and travel east across country to Great South Road. Travel north along the centre of Great South Road (9 - 269, odd addresses only included) to Browns Road, back to the starting point.

All residential addresses on included sides of boundary roads and all no exit roads off included sides of boundary roads are included in the zone unless otherwise stated.

Proof of residence within the home zone will be required.

Each year, applications for enrolment in the following year from in-zone students will be sought by a date which will be published in a daily or community newspaper circulating in the area served by the school. This will enable the board to assess the number of places which can be made available to students who live outside the home zone.

Special Programmes

This priority category is not applicable at this school because the school does not run a Special programme approved by the Secretary.

Out of Zone Enrolments

Each year the board will determine the number of places which are likely to be available in the following year for the enrolment of students who live outside the home zone. The board will publish this information by notice in a daily or community newspaper circulating in the area served by the school. The notice will indicate how applications are to be made and will specify a date by which all applications must be received.

Applications for enrolment will be processed in the following order of priority:

First Priority This priority category is not applicable at this school because the school does not run a

special programme approved by the Secretary

Second Priority will be given to applicants who are siblings of current students.

Third Priority will be given to applicants who are siblings of former students.

Fourth Priority will be given to any applicant who is a child of a former student of the school.

Fifth Priority will be given to any applicant who is either a child of an employee of the board of the

school or a child of a member of the board of the school.

Sixth Priority will be given to all other applicants.

If there are more applicants in the second, third, fourth, fifth, or sixth priority groups than there are places available, selection within the priority group must be by ballot conducted in accordance with instructions issued by the Secretary under Section 11G(1) of the Education Act 1989. Parents will be informed of the date of any ballot by notice in a daily or community newspaper circulating in the area served by the school.

Applicants seeking second or third priority status may be required to give proof of a sibling relationship.
